7.16	It was noted that a total of 98 employees were eligible to receive five types of social insurances in November 2019 according to the law. However, through review of social insurance enrollment list, 23 employees were enrolled in pension insurance, unemployment insurance; occupational rijury insurance; medical insurance and child-bearing insurance (Remark: the factory had provide a commercial accident insurance for all workers who did not enroll in social insurance.). 在此次审核过程中,审核员发现在98名符合参保条件的员工中,23名员工参加了养老保险,失业保险;工伤保险,生育保险和医疗保险(工厂给所有员工都提供了商业意外险)。  In accordance with Article 72 of China Labor Law: The employing unit and labourers must participate in social insurance and pay social insurance premiums in accordance with the law.  Article 73: Laborers shall, in accordance with the law, enjoy social insurance benefits under the following circumstances: (1) retirement; (2) illness or injury; (3) disability caused by work-related injury or occupational disease; (4) unemployment; and (5) child-bearing.	It is recommended that the factory should ensure all eligible employees are entitled with all five types of social insurance schemes and therefore receive all of their statutory welfare to comply with the Law.
